Description



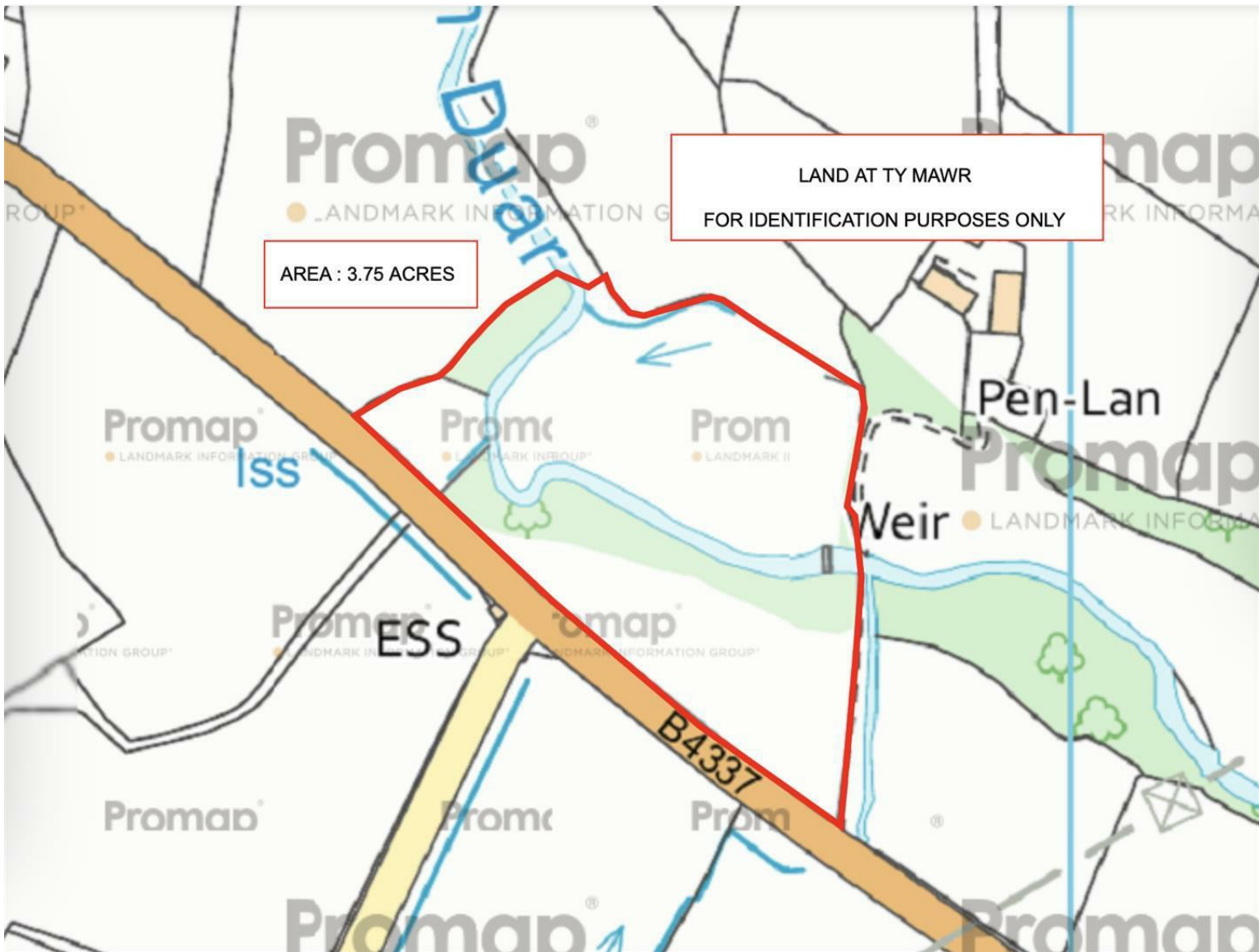
